WHEREAS, New Jersey women were particularly important in the establishment of early charitable, philanthropic and cultural institutions in our State; and

WHEREAS, New Jersey women of every race, class and ethnic background served as early leaders in the forefront of every major progressive social change movement; and

WHEREAS, New Jersey women have been leaders, not only in securing their own rights of suffrage and equal opportunity, but also in the abolitionist movement, the emancipation movement, the industrial labor movement, the civil rights movement and other movements, especially the peace movement, which creates a more fair and just society for all; and

WHEREAS, despite these contributions, the role of women in history has been consistently overlooked and undervalued in the literature, teaching and study of American history; and

WHEREAS, the Department of Community Affairs, specifically the Division on Women's goals are to remember and celebrate New Jersey women and to:

- Ensure that New Jersey women are offered equal opportunities in education, the workforce and healthcare regardless of age, sexual orientation, income, ethnicity, race or religion.
- Identify, implement, measure and coordinate programs that address the needs of New Jersey women.

WHEREAS, the Borough of North Plainfield prepared Bid Specifications and requested Bids for leaf, grass and brush pick-up and removal services for the Borough for calendar year 2011 (the "Project"); and,

REQUESTS FOR AGENDA ITEMS:

Mrs. Forbes stated that Senator Sweeney introduced a bill, S2794 regarding shared services and she would like it discussed.

PUBLIC COMMENT:

Hal Hirsch, 74 Mercer Avenue, questioned why the Borough is continuing to carry twice as much surplus in this budget. He questioned why there was \$20,000.00 added to the Planning Board's line. Why have certain salaries increased? He commented that the Recreation line has increased upwards of 5% which is more than the cost of living. He then commented that the leaf bid was thrown out last year and recently re-bid with only one bidder. Something doesn't seem right; perhaps the Borough should re-bid the project again.

Council President Stabile commented that Mr. Scognamiglio of Reliable Wood Products missed the bid this year due to their error as he was out of town. Mr. Bernstein added that the standard for awarding a bid is the lowest "responsible" bidder. The project was re-bid because one or more of the contractors were concerned about the language on the bids for an earlier round.

Council President Stabile advised that the Planning Board's increased funds are dedicated to the Master Plan update. Mr. Hollod added that the increases in the Health and Housing department will cover several salaries per the union contracts. Considering surplus, we're about on par with where we should be. These are unprecedented times. We've weathered the recessionary economy better than most. We can't borrow money, so surplus and reserves are good.

COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS:

Mayor Giordano announced that Recreation held its first Mayor's Cup on Saturday night. Unfortunately, we lost both games to Dunellen.

Mr. Singleterry commented that the State Assembly passed a bill today that will allow an income tax check-off box for Red Cross donations; it goes before the Senate next week. Congratulations and thanks to former Council President Nathan Rudy for his part in that.

Mr. Merrill shared that he had the privilege of coaching basketball season; it was a fun time and a fine season.

Mr. La Ronde echoed the Mayor's sentiments about the Mayor's Cup saying that it was a very enjoyable night for everyone.

Mr. Hollod, replying to Mrs. Forbes, stated that the Borough had just received a \$30,000.00 check representing a Local Access Grant from Comcast as part of the franchise agreement.
