Call to order at 7:01 pm. Chairman Sharp read the Compliance Statement.

#### **NEW APPLICATIONS**

**COA 01-04-10-2012, 103 Sycamore Avenue.** David Danois was sworn in. Mr. Danois explained the need to repair and/or replace in kind the wood trim, balusters, fascia and soffit elements on the house. The front porch steps and railings need to be repaired and/or replaced in kind and the asphalt and slate roofs need to be repaired and/or replaced in kind.
