The Board Chairman read the following Notice of Compliance:

BH-04-23-18-01 BE IT RESOLVED by the Board of Health of the Borough of North Plainfield that an ordinance numbered HO-18-02 be read by its title by the Secretary and be passed on its first reading and advertised as required by statute, fixing May 14, 2018 at 7:30 p.m. or as soon thereafter as the matter can be heard, as the time and the North Plainfield Borough Council Chambers, 263 Somerset Street, North Plainfield, New Jersey as the place for hearing and final adoption.

Seconded by Mr. Stabile and on Roll Call carried all four voting aye.

The Board Secretary read the Ordinance by its title as follows:

ORDINANCE NO. HO-18-02 AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD DEPARTMENT OF HEALTH, MOST NOTABLY CHAPTER XXVI, "BOARD OF HEALTH."
