MINUTES of the Regular (virtual) Meeting of the Council of the Borough of North Plainfield held on Tuesday, June 9, 2020 at 4:07 p.m. at the North Plainfield Borough Council Chambers, 263 Somerset Street, North Plainfield, New Jersey.

The Pledge of Allegiance to the Flag was led by Mr. Phoenix.

Council President Stabile requested a moment of silence for the men and women serving in our Armed Forces.

The Council President read the following Notice of Compliance:

"This virtual meeting is being held in compliance with N.J.S.A. 10:4-6 et seq. Adequate notice of this meeting was provided by transmitting notice to the official newspapers of the Borough, The Courier News, WKMB Radio, WJLP-TV, the Alternative Press and also to the Star Ledger on June 5, 2020 and by posting a copy of this notice on the bulletin boards in the Municipal Building and the Memorial Library reserved for such purpose."

Mayor Giordano read the Mayor's Call of Meeting:

I, Michael Giordano, Jr., Mayor of the Borough of North Plainfield, do hereby call a Special Meeting of the North Plainfield Borough Council for Tuesday, June 9, 2020 at 4:00 PM. Such Meeting is expected to be conducted by telephone/videoconference due to the current COVID-19 Virus Public Health Emergency declared by Governor Philip Murphy which requires social distancing measures that would not be achievable in the customary location in the Council Chambers at North Plainfield Borough Hall in addition to P.L. 2020, c.11.

The Borough Clerk is charged with providing proper notice of the Meeting to all applicable parties, setting up the technical parameters of the meeting, training the participants in the proper use/procedures of the telephone/videoconferencing methodology and conducting the Meeting in accordance with all governing statutes, including the allowance for public participation. The purpose of this Special Council Meeting is to consider and vote to introduce an amended Fair Share Housing Ordinance, consider and vote on an Ordinance to prohibit parking on a portion of Jennings Lane designated as a turnaround area, consider and vote on the introduction and approval of a Redevelopment Plan for the former Villa Maria Site, consider and vote on the designation of a developer to construct affordable housing on a portion of the former Villa Maria Site, consider and vote on a Resolution to authorize issuance of Estimated Tax Bills, vote on a Resolution to Authorize Use of Storm Recovery Reserves to protect our citizens during the current Covid-19 Health Emergency, make appointments to the Green Brook Flood Control Commission, approve payments of bills, and conduct any other such matters of business as may be necessary and required to be approved at an otherwise regularly scheduled Council Meeting. An Executive Session is called for the beginning portion of the Meeting immediately after Roll Call to discuss matters of pending/anticipated litigation with regard to the Borough's Affordable Housing Obligation, under the prerogative of Attorney/Client Privilege.

Discussion included an update relative to the Borough's on-going desire to seek compliance with their Affordable Housing obligation.

**RESOLUTION NO. 06-09-20-05f** RESOLUTION AUTHORIZING THE BOROUGH OF NORTH PLAINFIELD TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1994, c.72

WHEREAS, due to the late certification of rates from the State of New Jersey, the Somerset County Board of Taxation is unable to certify tax rates for the Borough of North Plainfield and the Tax Collector will be unable to mail the Borough's 2020/2021 tax bills on a timely basis; and

WHEREAS, the Borough of North Plainfield Tax Collector/Chief Financial Officer has computed an estimated tax levy in accordance with NJSA 54:4-66.3 and have signed a certification showing the tax levies for the prior year, the tax rates and the range of permitted estimated tax levies:

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of North Plainfield, in the County of Somerset and the State of New Jersey on this day of 9th day of June, 2020, as follows:

- 1. The North Plainfield Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Borough of North Plainfield for the third installment of the 2020 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by P.L. 1994, c.72 (NJSA 54:4-66.2 and 54:4-66.3)

WHEREAS, the bylaws of the Garden State Municipal Joint Insurance Fund require professional risk management consulting services to be performed; and

WHEREAS, the Business & Government Insurance Agency has offered its professional risk management consulting services to the Borough of North Plainfield for the Fund Year January 1, 2020 to December 31, 2020; and

WHEREAS, the Business & Government Insurance Agency has proposed compensation for its services in the amount of seven percent (7%) of the Borough's annual assessment as promulgated by the Garden State Municipal JIF.

**RESOLUTION NO. 06-09-20-05j** RESOLUTION AUTHORIZING AN EXTENSION FOR THE RENEWAL OF LICENSES FOR THE DISPLAY OR STORAGE FOR SALE OF MOTOR VEHICLES.

WHEREAS, pursuant to §4-10 of the Revised General Ordinances of the Borough of North Plainfield all licenses for the display or storage for sale of motor vehicles are issued for a term of one (1) year from July 1<sup>st</sup> to June 30<sup>th</sup> of each year; and,

WHEREAS, due to the impact that the COVID-19 pandemic has had on businesses that are required to maintain such licenses, the Borough finds that it is appropriate and necessary in these extraordinary times to extend the current license period for thirty (30) days until July 30, 2020, to allow licensees additional time to submit their applications for the renewal and approval of their licenses.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the current period for licenses issued for the display or storage for sale of motor vehicles is hereby extended for an additional thirty (30) days until July 30, 2020.

**RESOLUTION NO. 06-09-20-05k** RESOLUTION AUTHORIZING THE DESIGNATION OF REGION NINE UAW HOUSING CORPORATION AS REDEVELOPER OF THOSE CERTAIN PARCELS OF PROPERTY DESIGNATED AS BLOCK 110, LOTS 2.02 THROUGH 2.13 ON THE OFFICIAL TAX MAP OF THE BOROUGH OF NORTH PLAINFIELD.

WHEREAS, the Borough of North Plainfield ("Borough") previously determined that property designated as Block 110, Lots 2.02 through 2.14 on the Official Tax Map of the Borough (the "Property") also known as the Villa Maria site, is an area in need of redevelopment in accordance with the criteria set forth in the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq.; and,

WHEREAS, the Borough desires to designate a redeveloper for the development of low- and moderate-income family rental dwelling units on Lots 2.02 through 2.13 (Lot 2.14 will remain as open space) of the Property to help fulfill the Borough's Third (3rd) Round affordable housing obligations and implement the Borough's adopted Housing Element and Fair Share Plan; and,

WHEREAS, Region Nine UAW Housing Corporation ("RNHC"), a non-profit 501c(3) organization that was established in 1970 to sponsor, promote, and provide affordable housing to meet the needs of low to moderate income seniors, persons with disabilities, and families, proposes to develop up to twenty-four (24) units of affordable housing on Lots 2.02 through 2.13 of the Property; and,

WHEREAS, the Borough desires to designate RNHC as the redeveloper for Lots 2.02 through 2.13 of the Property as to the creation of up to twenty four (24) affordable housing units.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey as follows:

1. The above recitations are incorporated herein as if set forth at length; and,

- 2. RNHC is hereby designated as the Redeveloper for the redevelopment of Block 110, Lots 2.02 through 2.13 of the Property; and,
- 3. This designation is expressly contingent upon the Redeveloper being responsible for and assuming all costs incurred by the Redeveloper, including, but not limited to its own legal, appraisal, title, environmental, financial, engineering, etc.; and,
- 4. This designation is also expressly contingent upon the Redeveloper obtaining all funds necessary for the acquisition (if applicable), relocation, property maintenance, any and/or all of which amongst other things is necessary and at the Property and for the construction of the proposed Project; and,
- 5. The designation herein is for a period of two hundred seventy (270) calendar days, which period may be extended if necessary at the sole discretion of the Borough for an additional period of two hundred seventy (270) calendar days.

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk are hereby authorized to execute any and all documents and/or agreements necessary to effectuate this Resolution on behalf of the Borough, subject to review and approval of the Borough Attorney.

**RESOLUTION NO. 06-09-20-05***l* BE IT RESOLVED by the Council of the Borough of North Plainfield that the attached bills of the accounts named and for the amounts stated, having been duly audited and found to be correct as of this 9<sup>th</sup> day of June, 2020 the same be paid; and that the Mayor and Chief Financial Officer are hereby authorized to sign and deliver warrants for the same.

**RESOLUTION NO. 06-09-20-05m** RESOLUTION AUTHORIZING THE REVIEW OF APPLICATIONS FOR TEMPORARY COVID-19 EXPANSION OF PREMISES PERMITS PURSUANT TO SPECIAL RULING NO. SR 2020-10 OF THE DIRECTOR OF THE DIVISION OF ALCOHOLIC BEVERAGE CONTROL OF THE STATE OF NEW JERSEY.

WHEREAS, by Executive Order No. 150 (2020), Governor Murphy announced that, given the reduced transmission of COVID-19 outdoors, licensees or permittees with on-premises liquor retail consumption privileges would be permitted to reopen their establishments and serve patrons in outdoor areas; and,

WHEREAS, to facilitate this reopening, which is to become effective on June 15, 2020, the Director of the Division of Alcoholic Beverage Control (the "Division") has determined that it is necessary to create a temporary permit, known as the COVID-19 Expansion of Premises Permit ("COVID-19 Expansion Permit"), to enable licensees and permittees to expand their liquor licensed premises into outdoor areas, either contiguous or non-contiguous to their permanently licensed premises; and,

WHEREAS, on June 3, 2020, the Director of the Division issued Special Ruling No. SR 2020-10 establishing which licensees are eligible for COVID-19 Expansion Permits, the application process, and the privileges and limitations of the COVID-19 Expansion Permits; and,

WHEREAS, upon the submission to the Division of a completed COVID-19 Expansion Permit the application will be transmitted by the Division to the municipal clerk and police chief (or designee) of the municipality where the license is issued for municipal review; and,

WHEREAS, the Division will not take action on any application for a COVID-19 Expansion Permit until it receives an endorsement or approval by the appropriate municipal officials.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Clerk and the Borough Chief of Police (or designee) are hereby authorized to review and recommend for approval by the State of New Jersey, Division of Alcoholic Beverage Control all applications for COVID-19 Expansion Permits, without the need for any further action of this Borough Council, which meet all of the requirements of Executive Order No. 150 and Special Ruling No. SR 2020-10.

BE IT FURTHER RESOLVED that the Borough Clerk and the Borough Police Chief's (or designee's) recommendation for approval of such COVID-19 Expansion Permits shall be subject to the review and recommendation of any and all other appropriate Borough Officials and/or departments including, but not limited to, the Borough Fire Department and Zoning Official.

## **PUBLIC COMMENT:**

Eileen Chambers, 108 Jennings Lane, North Plainfield, thanked the Council for bringing forth Ordinance No. 20-03 which will restrict parking on the south side of the dead end on Jennings Lane.

Nick Yager, 450 Grove Street, North Plainfield, expressed concerns with the rehabilitation plan for the old Villa Maria property. He noted a potential discrepancy with the boundary designations which may exclude a portion of his driveway.

Nyja Canada, 144 Delacy Avenue, North Plainfield, voiced her concerns with vehicles speeding on Grandview Avenue between Sandford Avenue and Westervelt Avenue. Mr. Hollod assured that he would share her concerns with the Traffic Division of the Police Department.

## **REQUESTS FOR AGENDA ITEMS:**

Mr. La Ronde requested an update on the pet ordinance.

## COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS

Mayor Giordano recognized the North Plainfield High School student representatives for a peaceful demonstration, as well as members of the Police Department for taking the time to walk around and talk with the participants. The Fourth of July fireworks will be postponed until September 5. The Farmers Market will be held on Saturdays beginning June 27.

Reporting that all employees were back to full time hours in Borough Hall, Mr. Hollod noted that they continue to look at ways to safely reopen the building to the public.

Ms. Corzo thanked the students and the Police Department for a successful and peaceful demonstration.

Mr. Merrill reported on the Middle School gymnasium mercury levels which were nowhere near a harmful level. A power point is available on the Board of Education's website. Plans for a possible outdoor graduation are in the works for early July.

Ms. Miller commended the student organizers for a peaceful demonstration. For all to take a knee for the amount of time a black American lost his life was one of the most moving moments. Injustice anywhere is a threat to justice everywhere.

Reporting that June is Pride month, Mr. Singleterry suggested displaying Pride flags in recognition of same.

Council President Stabile thanked Messrs. Grygiel and Ceberio for their input with the Affordable Housing ordinances. He thanked the high school students and Police Department members for their participation in the demonstration. Reporting that many diverse people took a knee for eight minutes, it was quite powerful, he remarked. He then thanked his wife for dialing into the virtual meeting from Brazil.

Motion to adjourn by Ms. Miller seconded by Ms. Schaefer and on voice vote carried unanimously.
