- II. Pledge of Allegiance
- III. Attendance taken. Quorum met and meeting proceeded.
- IV. Public Comments
  - a. No public comments
- V. Review of April 2022 Meeting Minutes
  - a. Tom Allen mode motion to accept minutes. Seconded by Van Dickerson. No nays or abstentions. Motion passed.
- VI. Director's Report (given by Dennis Jackson unless otherwise noted)
  - a. Finance update
    - Dedicated trust currently \$159,681.87
  - b. Baseball / Softball
    - 1. 6 teams in the league
    - 2. Baseball approximately 15 coaches
    - ii. Softball
      - 1. Softball new applications for coaches coming in every week
      - 2. Softball 3 girl teams
      - 3. Season is a learning process / not very competitive so not to deter players from participating
      - 4. Clinics are being held with players and coaches
      - 5. Players seem to be happy and their confidence is building
    - iii. Pizza Contest Winners
      - 1. The contest winners are students from East End and Somerset
      - 2. Pizza party to be planned for all students participating in the program
      - 3. The party date is TBD
  - c. Field Repair
    - i. Played first game on Passe Field on April 25<sup>th</sup>
    - ii. The field was extremely damaged from storm Ida. It has been repaired and looks great

- iii. Games are currently being played at Passes Field, East End, and West End
- iv. Van Dickerson suggested a fence be put back in place at Passe Field
  - 1. Discussion tabled until June meeting

#### d. Newsletter

- i. Partnered with the board of education to be included in their newsletter
- ii. All events for the year have been included in the newsletter including contact information
- iii. The newsletter mailing to each home is scheduled to go out soon to every household in town mailing date TBD
- iv. Parks and Recreation section of the newsletter has already been posted on social media pages
- e. Summer Camp (Jen DeJesso)
  - i. Currently 115 children registered to Summer camp (exceeds normal number for this time of year)
  - ii. Early bird registration is open through May 14th
  - iii. Registration will remain open until July 1st (unless registration needs to be cut early)
  - iv. The maximum number of children that can be accepted in the program is approximately 145 depending on the number of counselors
  - v. Committee members requested to encourage anyone interested to register as soon as possible.
  - vi. \$100 deposit is required to hold a child's spot in the program
  - vii. Counselors are still needed / approximately 25 counselors would be ideal
  - viii. There may be some space issues.
    - 1. May not have the blue room this summer
    - 2. Downstairs may be utilized if HVAC system and other issues are addressed
