CONSENT AGENDA

Council President Stabile stated that all matters listed on the Consent Agenda are considered to be routine in nature and will be approved by one motion. There will be no separate discussion of these items. If any discussion is desired by Council, that particular item will be removed from the Consent Agenda and will be considered separately. Mr. McIntyre questioned item "e," sale of surplus property. Mr. George explained that "Municibid" had been checked out, and functioned like a public E-Bay. After the State's amendment to the Local Public Contracts Law, Municibid emerged as one of the larger such concerns. He concluded that municipalities are getting better sales results and much broader reach using Municibid. The items can be disposed of once they are advertised and receive no takers.

Mr. McIntyre asked about the electronic sign purchase included in the consent items. The Mayor said that it would be in front of the big tree on Borough property across from Borough Hall. It will be up in the air and controlled by wifi. Ms. Schaefer asked about power to the sign, and the Mayor explained that it would draw current from an electrical line that is already present at the location.

Mr. Merrill asked who would control the sign, and the Mayor replied that it would be controlled from his office, although the Police Department could access it in an emergency.

Mr. Merrill then asked for a separate vote on consent item "f."

WHEREAS, the Borough wishes to memorialize its approval of the Collective Bargaining Agreement; and,

WHEREAS, the estimate of Grotto Engineering Associates, L.L.C., the Borough's Engineer on the Project, was Four Hundred Eleven Thousand Two Hundred and Ninety Four Dollars (\$411,294.00) for the Project, indicating that the low bid is favorable and that, upon review, the low bid prices are reasonable; and,

WHEREAS, the Borough received an NJDOT Local Aid Grant in the amount of Three Hundred Ten Thousand Dollars (\$310,000.00) to perform the work; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M. REQUEST FOR AGENDA ITEMS:

The Council President requested that certain aspects of noise violations and the regulation of public gatherings be discussed at the scheduled August 15th Council Meeting

PUBLIC COMMENT:

Samuel Alofoje, 168 Norwood Avenue, asked about the Borough noise ordinance in reference to controlling loud parties and gatherings. He described a recent party near his home featuring two highly-amplified deejays and profanity, and reportedly called the police three times for noise enforcement on July 4th.

The Council President recalled how he and then Councilman La Ronde had championed the current noise ordinance which should be able to deal with pop-up parties. The Mayor said that the current noise ordinance is clear. Anything that you can hear inside your home is against the ordinance. For enforcement, residents should call the police non-emergency number, (908) 769-2937. If a fee is required to enter the gathering, it is illegal by law. Mr. Stabile rejoined that commercial events are illegal in residential zones.

Fitzgerald Tales, 150 Norwood Avenue, North Plainfield, (the prior speaker's neighbor) described the same event with cars parked up and down the street and strangers discarding bottles and litter.

Asked by Mr. Stabile about the frequency of the parties, Mr. Alofoje affirmed that they had been commonplace since 2018, with overbearing music that had driven a neighbor out of town. It appears that the next scheduled get-together is apparently July 24th. The gatherings appear to be attracting people from Brooklyn and New York City. Mr. Stabile commented that the gatherings raised multiple concerns, and the Mayor assured that he would check into the internet link for the parties. Ms. Schaefer advised that people should not be reluctant to phone the police if they were troubled by these incidents. The more calls, the better the enforcement will be, she assured.

On reports of liquor sales at the gatherings, the Mayor confirmed that liquor sales in themselves were illegal at such a gathering and sufficient for an immediate shutdown of such a party. Mr. Stabile asked if Mr. George could have a good look at the Borough's ordinances for enforcement opportunities, and the Mayor suggested that the town's gathering permit might answer some questions.

Mr. McIntyre questioned the penalties, and if they were escalating. Mr. George confirmed that there were escalating fines that could result in indictment, arrest and jail time. Ms. Miller suggested higher fines. Mr. George explained that they are statutory fines, and Ms. Miller suggested that regulations and fines be drawn up specifically for pop-up parties. The Mayor agreed that that could be a remedy, while the State Police have remained valuable resources for identifying possible local pop-ups. The Council President suggested that the matter be revisited at the next meeting scheduled for August 15th.

COMMENTS BY MAYOR, ADMINISTRATOR AND COUNCIL MEMBERS

Mayor La Ronde hoped that all enjoyed the parade and fireworks. He reminded of the Car Nutz Monday, July 18th car cruise on Somerset Street with a deejay and food vendor with three trophies offered. The Mayor's Wednesday evening Summer Concerts are being well received. He reported on a productive meeting with the Hispanic community, then advised of the Hope Social Services Academy wanting to come into the community with donated gifts for adults and children. No fees would be charged. They just require a staging area for their truck and trailer.

Mr. Hollod interjected his thanks for the support for tonight's bond ordinances, and Ms. Corzo welcomed him back. Ms. Given commented on how impressed she was with the first scheduled Mayor's summer concert, and Mr. McIntyre assured how terrific the parade and fireworks had been. He was particularly pleased with how the parade and the fireworks were held days apart, spreading out the joyous Independence Day celebration. Referencing the Apgar House, he reported briefly on volunteers meeting there on Saturday. He was particularly impressed with the volunteers' help with the cleanup.

Mr. Merrill congratulated Mr. Irovando and Recreation for all that they have done over the years to assure that the Independence Day celebration was memorable and better still from year to year, adding that he was the embodiment of a good volunteer.

Ms. Schaefer added her welcome back to Mr. Hollod, confirming how much she had enjoyed the 4th of July celebrations, particularly the fireworks and Community Day with all ages dancing.

Ms. Given reminded of the annual National Night Out celebration scheduled for August 2nd, remarking how popular the free hot dogs and hamburgers had become at every year's first Tuesday in August event.

Mr. Stabile concluded with his thanks to Mr. George for his skills as a wordsmith and to all involved in the deputy clerk search for their tireless efforts. He affirmed that Ms. Irby-Garry would serve us well. Echoing other previous speakers, the Council President expressed his admiration for

the parade, Community Day and fireworks which drew a record crowd. He agreed on Mr. Irovando's tireless dedication to the celebration, and finally welcomed back Mr. Hollod.
