WHEREAS, the Borough of North Plainfield has duly enacted a recycling plan for all recyclable materials as designated by the Somerset County Solid Waste Management Plan and amendments thereto codified in the Borough Code under section 14-7, "Recycling Program" and,

WHEREAS, pursuant to the Recycling Enhancement Act, N.J.S.A. 13:1E-96.2 et seq., the Borough of North Plainfield is in need of a Certified Recycling Professional to approve and sign a mandatory Annual Recycling Tonnage Report to be submitted to the New Jersey Department of Environmental Protection; and,

WHEREAS, the County of Somerset, a body politic having its offices located at 20 Grove Street, P.O. Box 3000, Somerville, New Jersey 08876 (hereinafter referred to as the "County"), has a Certified Recycling Professional on staff; and,

WHEREAS, while it is understood that the responsibility for the accuracy of all tonnage and materials reported lies with the Borough of North Plainfield, the Borough is desirous of retaining the services of the County's Certified Recycling Professional for the signing of said Annual Recycling Tonnage Report to be submitted to the New Jersey Department of Environmental Protection at a rate of Forty Four Dollars and Thirty-eight Cents (\$44.38) per hour as needed, not to exceed an annual amount of One Thousand Dollars (\$1,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council does hereby authorize the Mayor and Borough Clerk to enter into said contract with the County of Somerset, a copy of which is attached hereto and made a part hereof, for the services of the County's Certified Recycling Professional to sign the Borough's Annual Recycling Tonnage Reports at a rate of Forty Four Dollars and Thirty-eight Cents (\$44.38) per hour as needed, not to exceed an annual amount of One Thousand Dollars (\$1,000.00).

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk are hereby authorized to execute any and all documents on behalf of the Borough to effectuate this Resolution.

WHEREAS, the Borough of North Plainfield has approximately eighty (80) decorative street lighting poles along Somerset Street, which have been in place for some extended period of time; and,

WHEREAS, the Borough of North Plainfield is in need of professional engineering services to evaluate the structural integrity of the base connections for those decorative street light poles along Somerset Street and to identify whether any of the decorative street light poles' structural connections require repair and/or replacement (hereinafter referred to as the "Project"); and,

RESOLUTION AUTHORIZING THE GRANTING OF A PLACE TO PLACE TRANSFER APPLICATION PURSUANT TO TITLE 33 OF THE NEW JERSEY STATUTES TO MI MUNDO LATINO, L.L.C., AT PREMISES KNOWN AS 50-54 WATCHUNG AVENUE, PLENARY RETAIL CONSUMPTION LICENSE NO. 1814-33-001-003.

WHEREAS, pursuant to the provisions of N.J.S.A. 33:1-1 *et. seq.*, the Bridge Tavern, located at 50-54 Watchung Avenue, in the Borough of North Plainfield, County of Somerset and State of New Jersey, is a licensed premises for the sale of alcoholic beverages, pursuant to New Jersey State ABC Plenary Retail Consumption License No. 1814-33-001-003; and,

WHEREAS, the entity/person holding the plenary retail consumption license for said licensed premises is Mi Mundo Latino, L.L.C.; and,

WHEREAS, Mi Mundo Latino, L.L.C. has requested approval of a place to place transfer of said plenary retail consumption license noted above into an adjacent expanded space pursuant to a site plan approved by the Planning Board of the Borough of North Plainfield for the construction of an outdoor dining area wherein alcoholic beverages may be served, which requires a place to place transfer to permit the license holder to operate therein; and,

WHEREAS, the Borough of North Plainfield has reviewed the application of Mi Mundo Latino, L.L.C. for said place to place transfer including, but not limited to, the stockholders thereof and the record of the licensee showing that there are no known violations of local and/or state alcoholic beverage laws by the stockholders seeking the transfer or the current licensee; and,

WHEREAS, the North Plainfield Police Department has reviewed the application of Mi Mundo Latino, L.L.C. for said place to place transfer and performed an investigation as required by N.J.S.A. 33:1-1, *et seq.*, and reported to the Borough of North Plainfield that there are no known violations of local and/or state alcoholic beverage and/or criminal laws, or conditions which would impact the approval of said place to place transfer, Mi Mundo Latino, L.L.C., has supplied additional information requested by the North Plainfield Police Department in order to complete its report, of which the North Plainfield Police Department noted certain concerns which may affect the health, safety and welfare of the premises, patrons and residents in the area; and,

WHEREAS, in discussions with the representatives of Mi Mundo Latino, L.L.C., those certain concerns of the Borough of North Plainfield's officials were addressed, and certain

conditions were agreed upon by Mi Mundo Latino, L.L.C., as part of the application and its approval; and,

WHEREAS, the current licensee has satisfied all outstanding judgments against the current licensee and submitted paperwork to the Borough of North Plainfield evidencing the satisfactions of said judgements; and,

WHEREAS, publication of the transfer has been made in *The Courier News*, *The Star Ledger*, *The Alternative Press* and WKMB Radio and there were no objections received by the ABC Board prior to a hearing on this transfer; and,

WHEREAS, the Borough Council of the Borough of North Plainfield is of the opinion that the place to place transfer should be granted with the conditions stated below.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby approves and authorizes the place to place transfer of Plenary Retail Consumption License, No. 1814-33-001-003, held by Mi Mundo Latino, L.L.C., and operated at 50-54 Watchung Avenue in the Borough of North Plainfield to permit the operation of said plenary retail consumption license in and about the premises including expanded outdoor dining area with service of alcoholic beverages at the licensed premises, subject to the mandatory following conditions.

1. There shall be no music, whether recorded, live or electronically produced, played in the expanded outdoor dining area.
2. Service in and use of the expanded outdoor dining area shall end at 12:00am midnight on Friday and Saturday nights and 11:00pm on all other nights.
3. The gate to the rear driveway of 70 Pearl Street, which adjoins the property at 50-54 Watchung Avenue, shall remain locked and for the use of the owner(s) and/or tenant(s) of that property only.
4. The dumpster area shall be enclosed in such enclosure as required by the approval of the North Plainfield Planning Board for the site plan submitted to permit the construction of the outdoor dining area.

BE IT FUTHER RESOLVED that violation of any of the above conditions shall be grounds for revocation of the approval of applicant's place to place transfer, upon notice and an opportunity to be heard in accordance with N.J.S.A. 33:1-1; and,

NORTH PLAINFIELD POLICE FEBRUARY 2023 MONTHLY REPORT

ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers. Staffing and deficiencies:

- 2 Patrol Officers
- 1 SLEO III Officer

Injured Officers/Officers on Leave:

- Ofc. Alexis Castillo transitioned to light duty on June 2, 2022 for maternity leave. She returned to full duty on February 21, 2023.
- Sgt. Donald Everett has been out of work since July 27, 2022 for a non-work related surgery. He returned to light duty on September 14, 2022. He returned to full duty on February 5, 2023.
- Det. William Parenti Jr. was involved in a motor vehicle accident on November 9, 2022. He remains out of work.

Promotions, New Hires and Retirements:

- Effective February 6, 2023, Diana Galvez was hired as a Police Dispatcher.
- Effective February 6, 2023, Sabrina Brison was hired as a SLEO III.
- Effective February 20, 2023, Dispatcher Dalton Lott resigned.

CID Monthly Report

A Sample of Investigations & Arrests

On February 1, 2023 at 1611 hrs., an officer responded to a residence on a report of a possible fraud. The male victim reported that at 1030 hrs. he received a text message regarding his debit card being used for a purchase. He called the phone number and spoke to a person who pretended to be a representative from his bank. The representative advised the victim that an officer from the US Marshal's Service needed to talk to him. Another suspect, pretending to be with the Marshal's Service, told the victim that his social security number was being used in California to open multiple bank accounts tied to money laundering. The suspect also told the victim that he had a warrant for his arrest from the North Plainfield Police Department. The suspect told the victim that he could fix this situation by sending him \$6,000. The victim was directed to a business in Plainfield where he completed that request. After sending the money, he realized that something was odd about this process and he called the police.

NORTH PLAINFIELD POLICE FEBRUARY 2023 MONTHLY REPORT

On February 20, 2023, at 1900 hrs., patrol responded to residence for a report of a stolen vehicle. The victim stated that he arrived home, parked his vehicle, and left it running. He went inside the residence for about 10 minutes, came out, and the vehicle was gone. A neighbor observed a black vehicle parked nearby. The neighbor stated that four males approached the vehicle, entered it, and fled. The victim's phone was left inside the vehicle and pinging in the area of Grove Street and Prospect Place. Officers found the phone which was thrown out of the vehicle.

On, February 26, 2023, at 0615 hrs., patrol responded to a residence on Grove Street for a report of a robbery. A female victim reported that she works at a business on Front Street in Plainfield. She left work and was walking north on Grove Street when she observed a black male and a black female following her from Plainfield. The two individuals were described as wearing all black and the male had a face covering on. The victim started to run away from them and they ran after her. The male suspect grabbed onto her backpack and forcefully removed it from her possession. The male and female then ran south on Grove Street and made a left on Craig Place. Officers searched for the suspects with negative results. The victim was not injured during this incident.

Community Outreach

The Community Policing Unit made eighteen (18) first time alarm notifications and five (5) general alarm notifications. D/Sgt. Domizi assisted in numerous translations for both patrol & CID.

Narcotics Strike Force

The Task Force Officer assisted another agency in executing three (3) search warrants in North Plainfield. The Task Force also made four (4) undercover buys in North Plainfield. There was also a narcotics arrest made by the Task Force in North Plainfield.

CID tracked fourteen (14) Handle with Care notifications made to the school district. CID conducted six licensing investigations in February (5-Firearms, 1-Outdoor Cafe). Lt. Ciempola conducted four (4) Megan's Law re-registrations.
