WHEREAS, pursuant to *N.J.S.A. 40:48-1* and *N.J.S.A. 40:48-2*, the governing body of a municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order, and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and, as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

WHEREAS, this grant of authority includes the power to adopt reasonable ordinances for the regulation, permitting and licensing of various activities within the Borough and to ensure compliance with applicable Borough Codes; and,

WHEREAS, the Borough Council finds it necessary and appropriate to amend, revise and supplement such provisions of the Borough Code regarding licensing of various activities within the Borough to provide for a reasonable fee for such licenses and permits.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield be amended, revised and supplemented as to Chapter 4, entitled "General Licensing", more specifically § 4-1, entitled "Taxicabs" and, more specifically, § 4-1.2, entitled

“Taxicab Owners Company Licenses; Content And Manner Of Application; Fee and Term of Issuance” and, even more particularly, § 4-1.2(e), entitled “Fee For And Term Of License”; and, as to Chapter 4, entitled “General Licensing”, more specifically § 4-2, entitled "Coin Operated Amusement Devices” and, more specifically § 4-2.3, entitled "License Fee” and, as to Chapter 4 entitled “General Licensing,” more specifically § 4-6, entitled "Canvassers,” and more particularly § 4-6.3, entitled "Fee, Duration And Display”; and, as to Chapter 4, entitled “General Licensing,” more specifically § 4-10, entitled “Motor Vehicle Sale Regulation” and more particularly § 4-10.12, entitled “License Fees;” and, Chapter 6 entitled "Alcoholic Beverage Control,” more specifically § 6-3, entitled "Licenses” and, more particularly, § 6-3.7, entitled "Fees”; and, as to Chapter 11, entitled “Property Maintenance”, more specifically Article IV, entitled “Portable Storage Units (“PODS”) and, more particularly § 11-12.7, entitled "Permit Required,” as follows:

Section I

§ 4-1.2(e), entitled “Taxicab Owners Company Licenses; Content And Manner Of Application; Fee and Term of Issuance”, is hereby amended as follows:

Fee for and Term of License. All successful applicants for a Borough Taxicab license shall pay a fee of ~~\$500~~ \$650.00 for each and every taxicab license (each taxicab requires a license). Said taxicab license shall be issued and shall remain in full force and effect for a period of two (2) years from the date of issuance, unless it is received by the Borough or returned by the applicant prior to the expiration of the license.

Section II

§ 4-2, Coin Operated Amusement Devices, more specifically § 4-2.3, "License Fee,” is hereby amended as follows:

§ 4-2.3 License Fee.

The license fee for each proprietor as herein defined shall be ~~\$300~~ \$400.00 per year for each device used or played, or exhibited for use or play. All proprietors' license fees shall be payable annually in advance; provided, that where application is made after the expiration of any portion of any license year a license may be issued for the remainder thereof upon payment of a proportionate part of the annual fee. In no case shall any portion of the license fee be repaid to the licensee.

Section III

§ 4-6, entitled "Canvassers,” and more particularly § 4-6.3, entitled "Fee, Duration And Display,” is hereby amended as follows:

After due investigation, in accordance with the procedures and requirements of the North Plainfield Police Department, upon being satisfied that the applicant is of good moral character and that he is canvassing or soliciting for a project free from fraud, the Chief of Police, or in his absence, the officer in charge at Police Headquarters, shall have the power to grant a permit to canvass or solicit, upon the payment of the sum of ~~\$10~~ \$20.00 by the

applicant, which permit shall specify the number of hours or days the permit will be effective, provided however, that the permit will not be effective for a period in excess of sixty (60) calendar days, and further provided that no canvassing or soliciting shall be done except between the hours of 9:00 a.m. and 9:00 p.m. Monday through Saturday. Unless fingerprinted within the previous year, each applicant shall be fingerprinted and photographed before a permit shall be issued and copy of the photograph attached to the permit. Upon approval, each solicitor shall make a payment of a sum set by resolution for a permit either valid for no longer than sixty (60) calendar days or for a permit which is valid no longer than one calendar year. The permittee shall carry the permit and exhibit same to any police officer or other person upon request.

Section IV

§ 4-10 entitled "Motor Vehicle Sale Regulation," and more particularly § 4-10.12, entitled "License Fees," is hereby amended as follows:

The annual license fee shall be ~~\$550~~ \$650.00 for each lot having an area of five thousand (5,000) square feet or less, and an additional ~~\$140~~ \$200.00 for every one thousand (1,000) square feet or portion thereof in excess of five thousand (5,000) square feet; provided, however, that the maximum fee shall be ~~\$6,600~~ \$7,600.00 regardless of the number of square feet.

Section V

Chapter 6 entitled "Alcoholic Beverage Control," more specifically § 6-3, entitled "Licenses," and, more particularly § 6-3.7(a), entitled "Fees" is hereby amended as follows:

- a. License Fees; Number of Licenses. The annual fees of licenses for the sale and distribution of alcoholic beverages in the Borough shall be as follows:

The provisions of this subsection with respect to the limitation on the number of licenses shall not apply to the renewal or transfer of licenses presently issued.

The provisions of New Jersey's State Limitation Law, as provided in Chapter 72 of the Laws of 1960 and as the same may have heretofore or may be hereafter amended, shall control the number of and the issuance of plenary retail consumption and plenary retail distribution licenses.

- b. Application for Temporary Contingency Permit. Any person, firm, corporation or association making application for a temporary contingency permit pursuant to N.J.S.A. 33:1-74 shall pay an application processing fee of ~~\$10~~ \$20.00 to the Clerk of the Borough of North Plainfield.

Section VI

Chapter 11, entitled "Property Maintenance," more specifically Article IV, entitled "Portable Storage Units ("PODS") and, more particularly § 11-12.7, entitled "Permit Required," is hereby amended as follows:

- a. Upon placing a portable storage unit on his/her/its property, a person/company must submit an application and receive a permit from the Borough within ten (10) calendar days of its being placed on the property. Application for the permit shall be made to the Borough's Construction Official and shall require full name, address and other contact information for both the owner of the portable storage unit, the person/company contracting for the use of the portable storage unit and the owner/company of the property with which the portable storage unit is associated. A copy of the rental agreement shall also be attached. The application shall be accompanied by a permit fee of ~~\$20~~ \$40.00 as well as an insurance certificate confirming that the company and/or person supplying the portable storage unit maintain liability insurance in the amount of at least \$100,000 and naming the Borough as an additional insured and a certificate holder.
- b. Permits shall be granted for a total period of no more than ninety (90) calendar days for both noncommercial and commercial sites, as defined in subsection 11-12.4 herein. If a thirty (30) calendar day extension is granted, the applicant shall pay an additional fee of ~~\$20~~ \$30.00 for the extended period.
- c. The permit shall be affixed to the exterior of the portable storage unit.

NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.

BOND ORDINANCE NUMBER 23-14

BOND ORDINANCE PROVIDING FOR VARIOUS 2023 CAPITAL ACQUISITIONS AND IMPROVEMENTS, BY AND IN THE BOROUGH OF NORTH PLAINFIELD, IN THE COUNTY OF SOMERSET, STATE OF NEW JERSEY, APPROPRIATING \$4,167,275 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$3,276,005 IN BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NORTH PLAINFIELD, IN THE COUNTY OF SOMERSET, STATE OF NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements or purposes to be undertaken by the Borough of North Plainfield, in the County of Somerset, State of New Jersey (the "Borough"). For the said improvements or purposes stated in Section 3, there is hereby appropriated the aggregate amount of \$4,167,275, which amount includes a \$400,000 grant received or expected to be received from the State of New Jersey Department of Community Affairs Local Efficiency Achievement Program (the "LEAP Grant"), and a \$327,470 grant received or expected to be received from the New Jersey Department of Transportation (the "DOT Grant", and together with the LEAP Grant, the "Grants"), and \$163,800 as the aggregate amount of down payments for said improvements or purposes required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "Local Bond Law"). The down payments are now available by virtue of a provision or provisions in a previously adopted budget or budgets of the Borough for down payment or for capital

improvement purposes. Pursuant to N.J.S.A. 40A:2-11(c), as amended and supplemented, no down payment is required for the improvement or purpose set forth in Section 3(a)(vii) hereof, as such project is being funded by the DOT Grant, which is a grant provided by the State of New Jersey.

SECTION 2. For the financing of said improvements or purposes described in Section 3 hereof and to meet the part of said \$4,167,275 appropriation not provided for by application hereunder of the Grants and said down payments, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$3,276,005 pursuant to, and within the limitations prescribed by, the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Borough in a principal amount not exceeding \$3,276,005 are hereby authorized to be issued pursuant to, and within the limitations prescribed by, the Local Bond Law.

SECTION 3. (a) The improvements hereby authorized and purposes for the financing of which said obligations are to be issued are including, but not limited to, as follows:

(b) The above improvements and purposes set forth in Section 3(a) shall also include, as applicable, surveying, construction planning, engineering and design work, training classes, preparation of plans and specifications, permits, bid documents, construction inspection and contract administration, environmental testing and remediation and also all work, materials, equipment, labor and appurtenances as necessary therefor or incidental thereto.

(c) The aggregate estimated maximum amount of bonds or notes to be issued for said improvements or purposes is \$3,276,005.

(d) The aggregate estimated cost of said improvements or purposes is \$4,167,275, the excess amount thereof over the Grants and the estimated maximum amount of bonds or notes to be issued therefor, is the aggregate down payments for said improvements or purposes in the amount of \$163,800.

AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT CHAPTER 7 OF THE NORTH PLAINFIELD BOROUGH CODE, ENTITLED “TRAFFIC”, MORE SPECIFICALLY § 7-3, ENTITLED “PROHIBITED PARKING” AND, MORE PARTICULARLY, § 7-3.1B, ENTITLED “PROHIBITED PARKING PENALTY,” BY ADDING A NEW § 7-3.1B(c) ENTITLED “PARKING MONITORING AND ENFORCEMENT SYSTEM”.

WHEREAS, pursuant to *N.J.S.A. 40:48-1* and *N.J.S.A. 40:48-2*, the governing body of a municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

WHEREAS, this grant of authority includes the power to adopt reasonable ordinances for the regulation of conduct in and upon municipal parking locations to insure the safety of citizens in and about the Borough of North Plainfield and to obtain compliance with parking, traffic and other municipal codes; and,

WHEREAS, the Borough of North Plainfield hereby declares that, due to the parking of private or commercial vehicles in designated no parking zones or locations, traffic congestion in the Borough’s commercial and residential districts is increased; pedestrian, bicyclist and e-scooter users are exposed to additional safety risks; and, vehicular traffic is subject to reduced sight triangle vision in and around such designated no parking zones; and,

WHEREAS, the Borough of North Plainfield desires to install and utilize a parking monitoring and enforcement system ("System") at various locations within the Borough of North Plainfield to monitor and enforce parking by the North Plainfield Police Department in such locations which are designated as “no parking” zones or locations pursuant to this Chapter (§ 7-3) of the Borough Code; and,

WHEREAS, the Borough Council finds it necessary and appropriate to amend, revise and supplement Chapter 7 of the Borough Code, entitled “Traffic” more specifically § 7-3, entitled “Prohibited Parking” and, more particularly, § 7-3.1B, entitled “Prohibited Parking Penalty,” to add a new § 7-31.B(c), entitled “Parking Monitoring and Enforcement System”.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough of North Plainfield be amended, revised and supplemented as to Chapter 7 of the Borough Code, entitled "Traffic", more specifically § 7-3, entitled "Prohibited Parking" and, more particularly, § 7-3.1B, entitled "Prohibited Parking Penalty," to add a new § 7-31.B(c), entitled "Parking Monitoring and Enforcement System," as follows:

§ 7-3.1B(c) Parking Monitoring and Enforcement System is hereby adopted as follows:

§ 7-3.1B(c)(1) Installation of Parking Monitoring and Enforcement System.

- A. The Borough of North Plainfield hereby declares that, due to the parking of private or commercial vehicles in designated no parking zones or locations, traffic in the Borough's commercial and residential districts is increased, pedestrian, bicyclist and e-scooter users are exposed to additional safety risks and vehicular traffic is subject to reduced sight triangle vision in and around such designated no parking zones.
- B. The Borough of North Plainfield therefore determines that it needs to install and utilize a parking monitoring and enforcement system ("System") at various locations within the Borough of North Plainfield to monitor and enforce parking by the North Plainfield Police Department in such locations which are designated as "no parking" zones or locations pursuant to this Chapter (§ 7-3.1) of the Borough Code.
- C. The Borough shall have the authority to enter into a contract, following a lawful procurement process, for the installation of the System by a private parking monitoring and enforcement System provider.

§ 7-3.1B(c)(2) Issuance of Summons.

The Police Department of the Borough of North Plainfield shall review the recorded images produced by the System to determine whether sufficient evidence exists demonstrating that a parking monitoring and enforcement violation has occurred and shall issue a summons when appropriate in accordance with the Rules of Court governing the Courts of the State of New Jersey, in particular Article 7 of the Rules of Court, governing the Rules of the Municipal Courts.

§ 7-3.1B(c)(3) Use Of System Recorded Images.

- A. Except as otherwise provided in this Section or as otherwise by law or regulation, the recorded images produced by the System shall be available for the exclusive use of law enforcement officers of the North Plainfield Police Department for the purpose of discharging their duties to monitor and enforce all parking ordinances applicable in and about the Borough of North Plainfield.
- B. Any recorded image or information produced in connection with the System shall not be deemed a public record under *N.J.S.A. 47:1A-1 et seq.*, or common law. The recorded images shall not be discoverable as a public record by any person, entity or governmental agency, except upon a subpoena issued by a grand jury or a court order in a criminal matter, or offered

as evidence in any civil or administrative proceeding not directly related to a parking monitoring and enforcement system violation. This Section does not deny the right of a person charged with a parking violation under this Chapter to receive the same as discovery for the preparation of their case, and which shall be provided with service of any parking summons issued through the System by a law enforcement officer.

- C. Any recorded image or information collection in connection with any violation issued through the System by a law enforcement officer shall not be retained after sixty (60) calendar days following the resolution of any violation by collection of any fine or penalty or following any final adjudication by a court of competent jurisdiction. After the resolution of any violation by collection of any fine or penalty or following any final adjudication by a court of competent jurisdiction, the North Plainfield Police Department may purge such records without further action or authorization.
- D. If a summons is not issued within sixty (60) business days following the System assisted observation of a violation, all recorded images and any information collected with respect to the parking monitoring and enforcement system violation shall be removed by the North Plainfield Police Department within ten (10) business days thereafter.

§ 7-3.1B(c)(4) Owner's Liability.

The liability of the owner and operator of a motor vehicle for a violation or summons issued pursuant to the System shall be joint in accordance with the provisions and presumptions of the New Jersey Motor Vehicle Code.

§ 7-3.1B(c)(5) Violations and Penalties.

Any person liable for a System assisted violation or summons pursuant to this chapter and/or the New Jersey Motor Vehicle Code, utilizing the System, shall be subject to the following fines:

- A. Violation: Eighty (\$80.00) Dollars per violation.

A Sample of Investigations & Arrests

On June 1, 2023 at 2224 hrs., patrol responded to JFK Muhlenberg Medical Center in Plainfield on a report of an aggravated assault and an attempted robbery. The male victim, who is a resident of the borough, stated that while he was walking in the area of Mercer Avenue and Washington Avenue, an unknown male, wearing all black, approximately 5'6", slim build, with a ski mask on, demanded his belongings. The victim said no and the male then lunged at him with a sharp object, causing a deep laceration to his left wrist which was non life-threatening. The victim described the male as having an aggressive older voice and a distinct odor of lit cigarettes.

On June 4, 2023 at 0312 hrs., several police units responded to a residence on the east side of town with the North Plainfield Fire Department for a working structure fire. A police sergeant, who was first on scene, met the homeowner, who was able to walk out of the residence with his two dogs. He had minor burns to his facial area. The homeowner advised that his brother was still in the residence, upstairs, possibly in the bathroom. The homeowner stated that he was downstairs listening to music when he heard a loud bang. When he went upstairs to check on his brother, he observed smoke coming from the bedroom on the west side of the residence. When the smoke became stronger, he returned downstairs and exited the residence with the two dogs. The fire department arrived on scene and was told about the brother and his possible location. They made entry and located the brother face down in the bathtub. The victim was brought out and

treated by EMT's and paramedics and transported to St. Barnabas Hospital. The victim later succumbed to his injuries.

A Sample of Investigations & Arrests

The owner told the officer that he parked his vehicle in the front of the store near the east corner of the building, entered the store carrying a key fob, but left the vehicle unlocked and running. When he returned to the vehicle it was gone. The surveillance video showed a dark colored vehicle pull into the parking lot from Route 22 West. The vehicle pulled next to an 18-wheeler that was parked next to the victim's vehicle. Two individuals can be seen exiting that dark vehicle wearing all dark clothing. The stolen vehicle then flees onto Route 22 West with the dark vehicle following. The suspect(s) threw victim's phone out of the vehicle before fleeing. While investigating this theft, a resident of Fairview Avenue called police reporting a possible stolen vehicle that was abandoned on a street near his house.
