

**ORDINANCE NO. 17-14**

**BOROUGH OF NORTH PLAINFIELD  
COUNTY OF SOMERSET  
STATE OF NEW JERSEY**

**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT  
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,  
CHAPTER VII ENTITLED, "TRAFFIC",  
SECTION 7-10 ENTITLED,  
"TURN PROHIBITIONS",  
MOST NOTABLY, SECTION 7-10.2, ENTITLED "U-TURN PROHIBITION",  
SCHEDULE XV, ENTITLED "NO U-TURNS."**

**WHEREAS**, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to revise, amend and supplement Section 7-10 of the Borough Code of the Borough of North Plainfield, entitled "Turn Prohibitions"; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to make rules prohibiting certain turns on certain sections of public roads in the Borough of North Plainfield; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety are protected by prohibiting certain turns on certain sections of public roads in the Borough of North Plainfield.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Schedule XV of Chapter VII, Section 7-10.2 of the Borough Code of the Borough of North Plainfield, entitled "U-Turn Prohibition", is hereby revised, amended and supplemented by prohibiting U-Turns on the following streets in Schedule XV:

**SCHEDULE XV, NO U-TURN**

<b>SCHEDULE XV, NO U-TURN</b>	
<i>Name of Street</i>	<i>Location</i>
North Drive	North Drive from the southerly curb line of Route 22 east extending south to the northerly curb line of Mountain Avenue.
<b><u>Wilson Avenue</u></b>	<b><u>Wilson Avenue from the southerly curb line of Route 22 East extending south to the northerly curb line of Walnut Street</u></b>

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that:

1. Proper signage shall be erected after receipt of any approvals required pursuant to state or county regulations and requirements.
2. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.
3. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.
4. This Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
