Nine (9) Members Appointed by the Mayor

Terms of Office for three (3) types of Members:

- a. Type 1: Three (3) members shall have a term of three (3) years.
- b. Type 2: Three (3) members shall have a term of two (2) years.
- c. Type 3: Three (3) members shall have a term of one (1) year.
- d. All terms of office shall take effect on January 1 of the year of appointment, except during the first year.
- e. One (1) member of the Borough Council shall be appointed by the Council to serve as the Council's liaison to the Committee for a period of one (1) year.
